Upon confirmation, our BAC Secretariat will send you the detailed Eligibility Requirements.

Bidders are required to attend a pre-bid conference (via zoom video conference or face to face) to be conducted at QUEZELCO I Boardroom on February 7, 2024 at 1:00PM.


All bids submitted must be accompanied by a bid security in cash or manager's check equivalent to 2% of the Approved Budget for the Projects to be Bid.
