- Opening of Bids - August 22, 2024 (9:00 AM via Zoom or face to face)
- Notice of Award - 7 days from the date of confirmation of the Lowest Calculated & Responsive Bid
- Contract Preparation & Signing - Within 5 working days after issuance of Notice of Award


