6. The financial offer shall be listed on the space provided above.
7. The financial offer shall not exceed the Approved Budget Cost of **Php 1,976,000.00**
8. The ABC is VAT inclusive and the bid price should be VAT inclusive.
9. Term of payment : 90 calendar days after delivery completion.
10. Term of Delivery - FOB Pitogo
11. Performance Bond of 5% of contracted price shall be posted within 5 days upon receipt of notice of award.

**I. Transformer tank**

- Hot rolled steel, the tanks are MIG welded and possible leaks are tested using water immersion.
- Metal is prepared by shot blasting and passes through a 7 stage cleaning and zinc phosphate bath.
- Polyester powder coating** is electro-statically sprayed drying to a 3 mil-minimum film.
