
- Advertisement - 14 May 2026 (Philippine Daily Inquirer and NEA Website)

- Issuance of Bid Documents - May 14 until 8:30AM of June 2, 2026
- Pre-bid Conference - May 21, 2026 (1:00 PM face to face)
- Opening of Bids - June 2, 2026 (9:00 AM face to face)
- Notice of Award - 7 days from the date of confirmation of the Lowest Calculated & Responsive Bid
- Contract Preparation & Signing - Within 5 working days after issuance of Notice of Award
- Notice to Proceed - Within 5 working days after Contract Signing

A complete set of bidding documents may be purchased by the interested bidder upon payment of a non-refundable bid document fee stated above. Only bidders who have purchased the bidding documents may be allowed to attend the Pre-bid conference to be held at QUEZELCO I Boardroom on May 21, 2026 at 1:00PM.
